JESUSITA FIRE RECOVERY RESOURCES

The County is in the process of contacting all property owners affected by the Jesusita Fire. It is anticipated that a preliminary listing of damaged or destroyed properties will be released today, May 12, 2009. This list will continue to be updated as further property assessments in outlying areas occur.

County Executive Officer Michael F. Brown today appointed Michael Harris, Emergency Operations Chief, as the head of the County's recovery team that will help residents in the recovery and rebuilding process. The County's plans include assigning project case managers for area residents whose homes were lost or damaged in the Jesusita Fire. The County is also working to establish and open a recovery center similar to the one operated after the Tea Fire to provide information and assistance related to the rebuilding and recovery process.

Property Tags

County Building and Safety officials have inspected properties that sustained fire damage and tagged them with one of three tags which indicate structural safety: a red tag indicates a structure is unsafe to occupy; a yellow tag indicates that limited entry is possible and residents should enter at their own risk; a green tag indicates that the property was inspected and deemed safe to occupy. Areas unaffected by the fire will not be tagged. **If your property has a red tag, the structure is unsafe to occupy.**

Case managers have been assigned to properties damaged and/or destroyed. Residents may contact the Planning Supervisor, Petra Leyva, at 805-568-2071 to determine their case

manager. Residents should be prepared to provide property address, description of damage, and any other information the property owner may have. If the property is serviced by a septic tank, the case manager will need to know where the septic tank is located. Please also include any past service records of septic tank service. The property owner will then apply for a demolition permit. All fees will be deferred until a building permit is ready to be picked up. All permits will be a priority of the Planning and Development Department.

Recommendations for Ash Clean-Up

The Jesusita Fire created a significant amount of ash throughout the Santa Barbara, Montecito and Goleta area. While exposure to ash can cause irritation, short-term exposure generally does not constitute a significant health hazard for most people.

For minor clean-up of ash:

- Ashes in piles or clusters are best cleaned-up with a broom and dust pan.
- Deposit ashes in a sealed trash can to prevent wind from scattering them.
- A fine coating of ash may best be cleaned with wet mopping or water sprayed from a hose towards garden and lawn areas. Use the minimum amount of water needed to clean the surface, as water is in short supply. Avoid washing ash into the street and storm drains.
- Do not use leaf blowers or shop vacuums. They raise a significant amount of dust which may be inhaled, and will resettle and require further clean-up.
- Rinse fruits and vegetables from home gardens before eating them.
- Rinse children's toys and play equipment.

Residents working at sites burned in the Jesusita Fire are advised to follow the precautions below for their personal protection:

- Use a well-fitting dust particulate mask when cleaning up ashes. A mask rated N95 or P100 (available at paint and hardware stores) is most effective. If you do not have a mask, a damp cloth may be used to cover your nose and mouth.
- Children and individuals with asthma or other lung conditions should not be involved in ash clean-up.
- Protective glasses or goggles will help keep ash disturbed during clean-up out of your eyes. This is especially important for people wearing contact lenses.
- Minimize ash contact with bare skin by wearing long-sleeved clothing and pants.
- Wear leather gloves to protect hands from sharp objects.
- Wear boots with thick (lug) soles. Avoid tennis/running shoes, whose soles can melt or be punctured.

These precautions are not adequate for major clean up, rubble and debris removal where large quantities of ash are disturbed which may include asbestos-containing material.

- The only way to determine if asbestos is in a burned-out area is to have a certified asbestos consultant test the material. If it's suspected that there are asbestos-containing materials in the rubble, it is best to hire a certified asbestos contractor for cleanup.

- If it's suspected that there are asbestos-containing materials in the rubble and people choose not to hire a contractor for cleanup, the N95 respirator does not provide sufficient protection for major debris and rubble removal. People are advised to wear the P100 HEPA respirator – look for the words “HEPA” with magenta/purple colored filters.
- The P-100 HEPA respirators are available at most paint stores, building material stores, hardware stores and on-line. Note: only healthy individuals should even consider using a respirator as airflow into the lungs is significantly reduced.
